# Tourism and transport: Commission's guidance on how to safely resume travel and reboot Europe's tourism in 2020 and beyond

The Commission presents a package of guidelines and recommendations to help Member States gradually lift travel restrictions and allow tourism businesses to reopen, after months of lockdown, while respecting necessary health precautions.

The package also aims to help the EU tourism sector recover from the pandemic, by supporting businesses and ensuring that Europe continues to be the number one destination for visitors.

The Commission's Tourism and Transport package includes an <u>overall strategy towards recovery in 2020 and beyond</u>, a common approach <u>to restoring free movement and lifting restrictions at EU internal borders in a gradual and coordinated way</u>, a framework to support the <u>gradual reestablishment of transport whilst ensuring the safety of passengers and personnel</u>, a recommendation which aims to make <u>travel vouchers an attractive alternative to cash reimbursement for consumers</u>



and criteria for <u>restoring tourism activities safely and gradually and for developing health protocols</u> for hospitality establishments such as hotels.

ILO's preliminary assessment concerning the possible impacts of COVID-19 on the world of work and proposes a range of policy options to mitigate these impacts and facilitate strong and fast recovery

Based on different scenarios for the impact of COVID-19 on global GDP growth, at this point the ILO estimates indicate a rise in global unemployment of between 5.3 million ("low" scenario) and 24.7 million ("high" scenario) from a base level of 188 million in 2019. By comparison, the 2008-9 global financial crisis increased global unemployment by 22 million. According to the note COVID-19 and the subsequent economic shocks will impact the world of work across three key dimensions: 1) The quantity of jobs (both unemployment and underemployment); 2) The quality of work (e.g. wages and access to social protection); and 3) Effects on specific groups who are more vulnerable to adverse labour market outcomes.

The note calls for urgent, large-scale and coordinated measures across three pillars: protecting workers in the workplace, stimulating the economy and employment, and supporting jobs and incomes.
